1 Appearance Description

The overview of the cameras are shown as the figures below.




Figure 1-2 Type II Camera Overview

Notes:

- Only certain models support memory card installation and reset function.
- Power on the camera when pressing the RESET button, and press button for another 10 seconds to restore the default settings, including the user name, password, IP address, port No., etc.

2 Installation

Before you start:

- Make sure the device in the package is in good condition and all the assembly parts are included.
- The standard power supply is 12 VDC or PoE, make sure your power supply matches with your camera.
- Make sure all the related equipment is power-off during the installation.
- Check the specification of the products for the installation environment.
- Make sure that the wall is strong enough to withstand four times the weight of the camera and the bracket.
- Make sure that there is no reflective surface too close to the camera lens. The IR light from the camera may reflect back into the lens causing reflection.

2.1 (Optional) Install the Memory Card

Only certain models support memory card installation. Take type II as an example to describe the steps.

Steps:

1. Rotate the camera body to completely expose the memory card slot.

- 2. Loosen the screws to remove the memory card slot cover.
- 3. Insert the memory card into the slot, and push to get it mounted.

- 4. (Optional) To unmount the memory card, push to eject it.
- 5. Fix the screws to replace the slot cover.

2.2 Ceiling Mounting

Before you start:

Type I and Type II camera both support the ceiling mounting and the steps are similar. Here takes type II as an example to describe the steps.

Steps:

1. Disassemble the camera by pressing the button on the camera.






Figure 2-3 Disassemble the Camera

2. Paste the supplied drill template to the desired mounting position on the ceiling.




Figure 2-4 The Drill Template

3. Drill the screw holes or the cable hole in the ceiling according to the drill template.

Note: Drill the cable hole if adopting ceiling outlet to route the cable.

4. Fix the mounting base on the ceiling with supplied screws.

Note:

- In the supplied screw package, both self-tapping screws, and expansion bolts are contained.
- If the ceiling is cement, expansion bolts are required to fix the camera. If the ceiling is wooden, self-tapping screws are required.
- 5. Route the cables through the cable hole, or the side opening.
- 6. Install the camera body back to the mounting base.






Figure 2-6 Install the Camera Body

7. Connect the power cord and network cable.

- Power on the camera, and set the network configuration. For details, refer to 3 Set the Network Camera over the LAN and 4 Access via Web Browser.
- 9. Adjust the surveillance angle.




Figure 2-7 Adjust Surveillance Angle

- 1). Hold the camera body and rotate the enclosure to adjust the pan angle [0° to 360°].
- 2). Move the camera body up and down to adjust the tilt angle [0° to 75°].
- Rotate the camera body to adjust the rotation angle [0° to 360°].

2.3 Wall Mounting

Before you start:

- Type I and Type II both support wall mounting and the steps are similar. Here takes type II as an example to describe the steps.
- You need to purchase a wall mounting bracket separately.

Steps:

1. Disassemble the camera by pressing the button on the camera.




Figure 2-8 Disassemble the Camera

Drill screw holes in the wall according to the holes of the bracket and install the bracket to the wall with screws.

3. Install the mounting base to the bracket with screws.




Figure 2-10 Install the Mounting Base to the Bracket

 Repeat steps 5 to 9 of 2.2 Ceiling Mounting to complete the installation.

2.4 Mounting with Junction Box

Before you start:

- Type I and Type II both support mounting with junction box and the steps are similar. Here takes type II as an example to describe the steps.
- You need to purchase a junction box separately.

Steps:

1. Disassemble the camera by pressing the button on the camera.




Figure 2-11 Disassemble the Camera

2. Paste the supplied drill template to the desired mounting position.




Figure 2-12 Drill Template

- 3. Drill the screw holes according to the drill template.
- (Optional) If you want to route the cables inside the wall, drill a cable hole in the wall according to the adapter plate.
- Take apart the junction box, and fix the camera mounting base on the junction box's cover with screws.




Figure 2-13 Fix Mounting Base on the junction box's Cover

6. Secure the junction box's body on the wall with screws.




Figure 2-14 Secure the Junction Box's Body on the Wall

Combine the junction box's cover with its body with supplied screws.

8. Repeat steps 5 to 9 of 2.2 Ceiling Mounting to complete the installation.

2.5 Mounting with Inclined Base

Before you start:

- Type I and Type II both support mounting with inclined base and the steps are similar. Here takes type II as an example to describe the steps.
- You need to purchase an inclined base separately.

Steps:

1. Disassemble the camera by pressing the button on the camera.




Figure 2-16 Disassemble the Camera

- 2. Paste the inclined base's drill template to the wall.
- Drill screw holes and the cable hole (optional) on the wall according to the supplied drill template.

Note:

Drill the cable hole, when adopting ceiling outlet to route the cable




Figure 2-17 Drill Template

Disassemble the inclined base and install the camera's mounting base on the inclined base cover with screws.

5. Install the inclined base's body on the wall with screws.




Figure 2-19 Fix the Inclined Base's boy on Ceiling/Wall

6. Combine inclined base's cover with its body with screws.

7. Repeat steps 5 to 9 of 2.2 Ceiling Mounting to complete the installation.

2.6 Waterproof Measures

If the camera is installed outdoor, you should use the waterproof accessory or tapes to waterproof the cables. Otherwise the cables might get wet or a short circuit occurs.

2.6.1 Install Network Cable Waterproof Jacket




Figure 2-21 Install Waterproof Jacket

Steps:

- 1. Feed the network cable through 1 and 3 in order.
- 2. Fix (2) on the network cable between (1) and (3).
- 3. Place (5) onto the end of (6), and plug the RJ45 male connector into RJ45 female connector.
- 4. Screw (3) to (6) clockwise.
- 5. Push (2) into (3).
- 6. Secure (1) with the (3) in clockwise direction.

2.6.2 Waterproof Other Cables

After routing and connecting the cables, use the waterproof tapes to wrap up the cables. Connected cables and spare cables both should be wrapped up as the figures below.




Figure 2-22 Waterproof Cables

3 Set the Network Camera over the LAN

Note:

If your camera is used with NVR, refer to user manual of NVR for further operations. Otherwise, follow the steps below.

3.1 Wiring

Connect the camera to network according to the following figures.

3.2 Activate the Camera

You are required to activate the camera first by setting a strong password for it before you can use the camera.

Activation via web browser, activation via SADP, and activation via client software are all supported. We will take activation via SADP software and activation via web browser as examples to introduce the camera activation.

Note:

Refer to the User Manual of Network Camera for activation via client software.

3.2.1 Activation via Web Browser

Steps:

- 1. Power on the camera. Connect the camera to your computer or the switch/router which your computer connects to.
- Input the IP address into the address bar of the web browser, and press Enter to enter the activation interface.

Notes:

- The default IP address of the camera is 192.168.1.64.
- The computer and the camera should belong to the same subnet.
- For the camera enables the DHCP by default, you need to use the SADP software to search the IP address.

3. Create a password and input the password into the password field.

- 5. Click OK to save the password and enter the live view interface.

3.2.2 Activation via SADP Software

SADP software is used for detecting the online device, activating the camera, and resetting the password.

Get the SADP software from the supplied disk or the official website, and install the SADP according to the prompts.

Follow the steps to activate the camera.

Steps:

- 1. Run the SADP software to search the online devices.
- 2. Check the device status from the device list, and select the inactive device.

You can check whether the activation is completed on the popup window. If activation failed, make sure that the password meets the requirement and try again.

3.3 Modify the IP Address

Purpose:

To view and configure the camera via LAN (Local Area Network), you need to connect the network camera in the same subnet with your PC.

Use the SADP software or client software to search and change the IP address of the device. We take modifying the IP Address via SADP software as an example to introduce the IP address modification.

For IP address modification via client software, refer to the user manual of client software.

Steps:

- 1. Run the SADP software.
- 2. Select an active device.
- Change the device IP address to the same subnet with your computer by either modifying the IP address manually or checking the checkbox of Enable DHCP.

4 Access via Web Browser

Display: 1024×768 resolution or higher

Web Browser: Internet Explorer 8.0 and above version, Apple Safari 5.0.2 and above version, Mozilla Firefox 5.0 and above version and Google Chrome 18 and above version

Steps:

- 1. Open the web browser.
- In the browser address bar, input the IP address of the network camera, and press the Enter key to enter the login interface.

Note:

The default IP address is 192.168.1.64. You are recommended to change the IP address to the same subnet with your computer.

3. Input the user name and password.

The admin user should configure the device accounts and user/operator permissions properly. Delete the unnecessary accounts and user/operator permissions.

Note:

The device IP address gets locked if the admin user performs 7 failed password attempts (5 attempts for the user/operator).

4. Click Login.

5 Operate via Guarding Vision App

Purpose:

Guarding Vision is an application for mobile devices. With the App, you can view live image of the camera, receive alarm notification and so on.

Note:

Guarding Vision service is not supported by certain camera models.

5.1 Enable Guarding Vision Service on Camera

Purpose:

Guarding Vision service should be enabled on your camera before using the service.

You can enable the service through SADP software or web browser.

5.1.1 Enable Guarding Vision Service via SADP Software

Steps:

- 1. Check the checkbox of Enable Guarding Vision on:
 - 1). "Activate the Device" page during camera activation, refer to Chapter 3.2.2.
 - Or "Modify Network Parameters" page during modifying IP address, refer to Chapter 3.3.
- 2. Create a verification code or change the verification code.

- 3. Select Platform Access Mode as Guarding Vision.
- 4. Check the checkbox of Enable.
- 5. Click and read "Terms of Service" and "Privacy Policy" in pop-up window.
- Create a verification code or change the verification code for the camera.

The verification code is required when you add the camera to Guarding Vision app.

7. Save the settings.

5.2 Guarding Vision Setup

Steps:

- Download and install the Guarding Vision app by searching "Guarding Vision" in App Store or Google PlayTM.
- 2. Launch the app and register for a Guarding Vision user account.
- 3. Log in Guarding Vision app after registration.

5.3 Add Camera to Guarding Vision

Before you start:

You need to enable the Guarding Vision service on camera before adding it to your Guarding Vision account. Refer to Chapter 5.1.

Steps:

 Use a network cable to connect the camera with a router if the camera does not support Wi-Fi.

Note:

After the camera connects to the network, please wait one minute before any operation on the camera using Guarding Vision app.

2. In the Guarding Vision app, tap "+" on the upper-right corner and then scan the QR code of the camera to add the camera.

You can find the QR code on the camera or on the cover of the Quick Start Guide of the camera in the package.




Figure 5-4 Scan QR Code

Note:

If the QR code is missing or too blur to be recognized, you can also add the camera by tapping disconting inputting the camera's serial number.

3. Input the verification code of your camera.

Note:

- The required verification code is the code you create or change when you enabling Guarding Vision service on camera.
- If you forget the verification code, you can check the current verification code on Platform Access configuration page via web browser.
- Follow the prompts to set the network connection and add the camera to your Guarding Vision account.

Note:

For detailed information, refer to the user manual of the Guarding Vision app.

5.4 Initialize the Memory Card

Steps:

Check the memory card status by tapping on the Storage Status in the Device Settings interface.

If the memory card status displays as Uninitialized, tap to initialize it. The status will then change to Normal. You can then start recording any event triggered video in the camera such as motion detection.
